#### 6. Planning Applications

6.1 2022/1913, Erection of 36 units together with garaging and associated access and infrastructure, Land West of Round House Way (amendment). Previous objection retained as the changes requested in the response of December 2023 had not been addressed.

#### 8. To receive an update on matters affecting new developments

7.1 Big Sky (St Giles Park).

The opening event for The Jubilee Centre had been held on 29 November, which had been a success. RS had raised the matter of the fence along the A11 with Big Sky. Big Sky had confirmed that hawthorn hedging would be planted, not a formal fence.

7.2 Tilia Homes (Roundhouse Gate)

No update.

7.3 Barratt David Wilson Homes / Crest Nicholson (Cringleford Heights)

An update was received on the allotment and LEAP transfers. Following a meeting, BDWH had agreed that access to site could be across the footpath for grounds

vehicles, without CPC having to accept any liability.

BDWH had attempted to remove barbed wire from the allotment hedge line, as requested by CPC. A neighbour felt that they had damaged their hedge whilst carrying this out. They had been put in contact with developers who had agreed to replant. If this was not satisfactory then Heras fencing could be put into place. The barbed wire still needed to be removed before adoption could take place. It was noted that some of the hedgerow was dead and may need to be replaced by CPC in the future.

TW noted that a full grant had been received to install two EV chargers at The Willow Centre. Norfolk would take the revenue and pay for the electricity. Maintenance and costs would be covered by Norfolk County Council for seven years and so there would be no cost to CPC.
